- 1954 Establishment of Kumsung Industry Corporation**
 In 1954, Kumsung Industry Corporation was established as a professional import and export company and designated as Korea's 2nd General Trading Company in 1975.
- 2004 Expansion of Logistics**
 GS Global opened Korea's first and biggest PDI center for automobile imports in Incheon as a part of the business diversification plan. The PDI center was converted into a corporation as 'PLS' and was relocated to Pyeongtaek in 2011.
- 2009 Integrated into GS Group**
 GS Global was officially integrated into GS Group in July 2009. GS Global has been playing the key role as GS Group's overseas business platform and taking a leap forward to become the "Value No.1 Solution Provider".
- 2010 Merged with GS Entec**
 GS Global merged with GS Entec, a chemical machinery and power generator producing company, as a part of its plan to secure future growth engines.
- 2017 Investment in BSSR**
 GS Global acquired shares of BSSR, one of the largest coal mining companies in Indonesia, and obtained the off-take right to secure BSSR coal. BSSR produces 15 million tons of thermal coal on a yearly basis. GS Global will diversify its coal trading portfolio through various types of business models.
- 2020 Developing SOC Business**
 GS Global established its subsidiary called 'Gyeonggi Pyeongtaek Global' to develop SOC project which is centered in Pyeongtaek port, the hub of logistics business. The company was also nominated as the developer for the port-hinterland construction project, a seashore reclamation near Pyeongtaek port.

COAL

GS Global promotes various types of coal business to achieve stable business portfolio covering Upstream & Midstream sectors.

Business Fields

Coal makes essential energy source for industrial development and GS Global commercializes it in diverse areas. GS Global is expanding its activities in triangular trade and importing business. In 2017, GS Global has successfully invested in Indonesian mines and is also actively seeking further mine investments in Australia and Indonesia to stretch its business scope to the upstream fields.

Major Business Activities

Since 1978, with 40 years of accumulated experience and know-how, GS Global specializes in handling multi-origin thermal coal including Indonesian, Russian and Australian. Despite volatility of the global coal market, demand for coal within Korea has been stably increasing for the past few decades. Along with such trend, the team's role is also being enlarged in responding to the rising demand from expansion of coal fired power plants within GS Group and general industry markets in Korea. We are also actively supplying thermal coal to the Chinese market with Indonesian origin, sourced from its own off-take tonnage and various named miners.

BSSR

GS Global acquired shares in BSSR and obtained off-taking rights to secure BSSR / AGM coal and expanded its coal trading portfolio. BSSR is one of the major Indonesian coal mining companies in Indonesia that produces 15 million tonnes of thermal coal per annum from its own mining operation in East Kalimantan (BSSR Mine) and its 100% subsidiary mining company AGM Mine in South Kalimantan.

GS Global is aiming to be the leading logistics company with its logistics-specialized subsidiary of PLS Corp. To this end, we have provided premium PDI (pre-delivery inspection) services for imported cars and expanded the value chain of logistics and automobile maintenance techniques based on our experiences in PDI services.

Business Fields

Our services consist of PDI business of imported cars [unloading, storing, PDI, shipping to dealers], unloading and transporting business, and special vehicle manufacturing business.

Major Business Activities

With almost 30 years of accumulation of know-how in the PDI business for imported cars, we created a large-scale PDI facility of approximately 221 thousand square meter at the free trade zone near Pyeongtaek port on the west coast of Korea. By utilizing our large-scale PDI facility, we are able to provide the best services to automobile companies such as Honda, Toyota, Audi, Volkswagen, Volvo, Polestar, and BYD buses and trucks with our latest PDI system, allowing us to secure the dominant market share in Korea.

Furthermore, we are constructing new PDI facilities continuously to expand PDI business and attract new PDI customers.

We also launched unloading and transporting services in 2014 and currently unload and transport energy fuels such as PKS (palm kernel shells), wood pellets, and thermal coal through Pyeongtaek Port.

Lastly, our special vehicle manufacturing business unit manufactures and supplies aircraft refueling vehicles for domestic and overseas clients with the production capacity of over 80 vehicles per year. Currently, we export aircraft refueling vehicles to Pakistan and Egypt. Moreover, we are not only planning to expand our target markets to Southeast Asia and the Middle East but also diversifying the product line to hydrant dispensers, aerial platform trucks, fire trucks, etc.

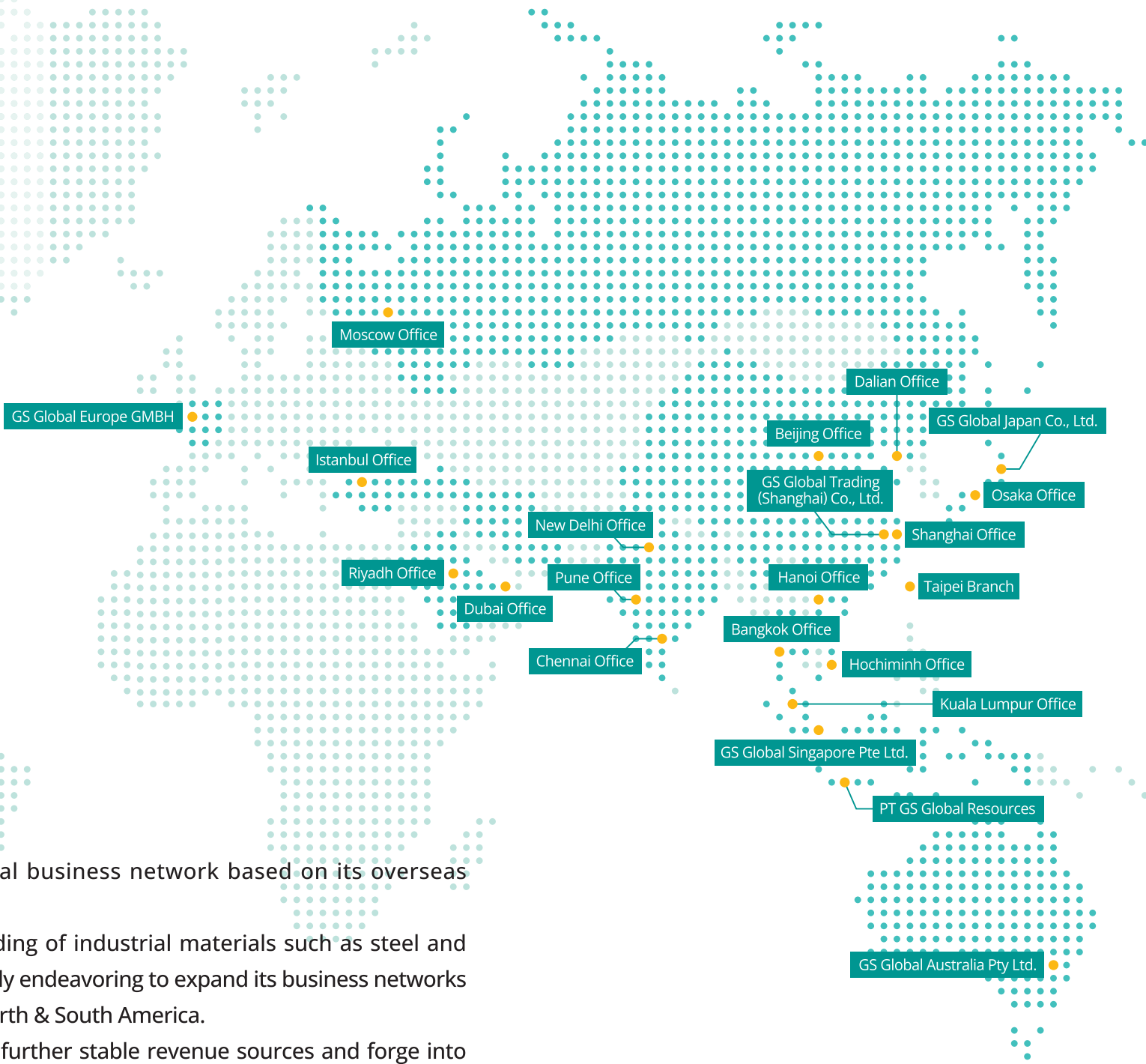
